First Responders' Resource Fair, 10/09/2019

WAStateC.O.P.S. received an invitation from Sgt. Sorenson of the Snohomish County Sheriff's Office to participate in their first (hopefully) annual First Responders' Resource Fair held on October 9, 2019 at the Gold Creek Community Church in Mill Creek, Washington. This was an all-day event and attended by over 100 people from western Washington. Chapter President Penny Brenton and I represented WAStateC.O.P.S.

The invited attendees were administrators of first responders such as the command staff for Police and Fire agencies, Peer Support Counselors and Chaplains throughout western Washington. The goal was to bring first responders and support services together in one place so first responders could meet and learn about some of the services available to them.

There were two keynote speakers from Deer Hollow and Bella Monte, both recovery and treatment centers for first responders.

WAStateC.O.P.S. was assigned one of the breakout sessions in the morning and again in the afternoon for a 30-minute presentation each time. We had put together a slide presentation and talked about National C.O.P.S. and WAStateC.O.P.S. Most of those attending had no idea of the scope of C.O.P.S. programs and were very impressed.

When we were not talking in our breakout session, we had a table of information and handouts and were able to talk to a lot of people about our programs and services. Most expressed heartfelt gratitude for what we (C.O.P.S.) do.

This First Responders' Resource Fair was a well-put-together program and I hope it will be an annual event.

My First Siblings Retreat, by Tracy Page Winder

For many years I have wanted to attend a C.O.P.S. Siblings retreat, but my job doesn't always allow me to take that time off during that time of the year. This year, I trained a friend and she covered for me. Two months ahead of time I purchased a ticket and a shuttle to SeaTac airport. Our chapter helps us attend by offering up to \$600 for retreats.

When I arrived at the airport in Missouri, I met other siblings in the meeting room where people wait until the bus leaves for Potosi. There were a few people, and an abundant stack of pizzas. I met a few people, and we were on our way. About an hour and a half into the ride, the bus slowed down and pulled over. The driver told us we weren't going anywhere for a while. He got off and went to the back of the bus to look at the problem. Being mechanically inclined, I took it upon myself to go out there and ask him if there was anything I could do to help. It was obviously a blown fan belt but unfortunately the right backup belt wasn't on the bus. We waited patiently in the bus in the heat until he got the AC running. A short bus picked us up and transported us to the lodge. We had a fun bunch on the bus, and we bonded during the delay.

It was amazing pulling into the lodge and seeing a large crowd in front of the lobby yelling and cheering us on for arrival! We were then told that the food was held for us and we had 25 minutes to go in and grab something to eat. Camp food was like eating in a school lunch room!

Following dinner I was shown to my room and met my roommate who I would spend the weekend with - what a fabulous person, with a southern accent, made feel right at home as my family lives in Texas and she does too!

We then went to a welcome meeting and signed up for activities for the next couple of days. I signed up for shooting class and a paint class!

I shot an old fashioned .22, got some excellent pointers, and hit the balloon on my first try. Then I hit the poker chip and the playing card, which was a 2 of Hearts. The Missouri conservation staff was so helpful and nice, and one of them looked like my brother's best friend. And, yes, I also did sing an AC/DC song at karaoke!

The first morning we met in a room with a dozen siblings sharing stories of their loss. That was hard but much needed, it was good to see that. We all shared grief in different ways, but we all live on in respect for their sacrifices! The final night it was fun sharing laughter and closing by sending messages to our loved ones in hot air balloons!

I really appreciated the counselors, including one who helped me and gave me practical tools.

It's amazing that you go so far from home and find people that you have so much in common with.

My best advice to survive this pain of loss is to attend your retreat. It is great for your soul, and you will not regret it! I hope to attend again! Many thanks for the C.O.P.S organization that makes all of this possible, and WAStateC.O.P.S. for their help!


